Chair Dedman: any other questions? Hon. D. Tso: number 1 is your supporting resolution leg. 0153-20. I appreciate the fact	
that this was put on the agenda to basically to make known its intent and purpose- do	
what the Navajo people voted on in 2009 ballot question. The language should be similar	
to what is in the blue book of Title 2. The other aspect would be something that the	
CNGD would consider themselves to do on the referendum language. The main thing is	
what is before you now. As you know, there is some abuse. It evolves from former AG	
Ethel Branch's opinion. We think it is wrong, that is why I'm sponsoring this legislation.	
Hon. P. Begay: I'm just listening in right now. Thank you.	
Comm. Morgan: a Special Meeting was called for the Commissioners. There was an	
agenda put forth. The definition was explained by Mr. Dee. We have a general	

understanding of what is before us. Madame Chair this is a Commissioner's meeting, I call for the Question.	
Chair Dedman: before we go to voting, I would like to give everyone a chance to speak.	
Comm. Bluehouse: with the veto, we have the funds tied up. We need to funds to get	
things done, because we are in an emergency situation with Covid-19. I want people to	
use the funds.	
Comm. Begay: the issue we are discussing, it was talked about in June. I was not on the	
line for the first meeting. I was on the call, the second time. There was really no	
explanation on the legislation, due to it already being discussed. What is the exact	
meaning? I listened to Mr, Dee's explanation and understand. To this point, the law is not	
being used properly. It is being abused. With all the explanation I heard today, I'll	
support it. Along with Mr. Bluehouse question, how do we plan to address that?	
Comm. Willie: I am in support of this resolution. In order to maintain the balance, we	
cannot allow too much power to one branch. I just wanted to express mt support in this resolution.	
Chair Dedman: any others? Will have Ed answer Bluehouse question.	
Mr. Dee: let me go back to Del. Henio's comment. The data that he eluded too; we have	
the data on the uptick. This administration has really shown its use and misuse of this	
application, which we will include as part of the public comments later today.	
Next question, they way I read the description. 0602-20 is separate and has already been	
passed. That is a separate fix, to this fix. We do have the transcript from the Title 2	
subcommittee meeting. This resolution is supporting 0153-20. The previous resolution is	
for the referendum, when we solidify the election.	
Chair Dedman: shizhe'e Comm. Bluehouse, was your question answered?	
Comm. Bluehouse: No. There seems to be a very strong urgency. Right now, we are	
dealing with legislations, modifications and so forth. We should get this out to the	
people. What can we do? What authority can we develop or propose that can address	
that area? We need to move right along and get the help to the people- water lines,	
electric system, etc. It has to do with health and mental health. This Commission should be in the position to move in that direction to advocate language change, which is good	
and well. The election is good by the people- it is clear. We need to get away from the	
political shenanigans and maneuvering. We are dealing with people's lives, well-being. I	
just want to make that emphasis and stand on that.	
Chair Dedman: perhaps that is a topic for the regular meeting. Ed, can you see how we	
can address that.

Comm. Rodgers: can I make a statement? I am quite supportive of what Mr. Bluehouse is	
suggesting; perhaps, under Reports. Have someone or group that is working with the

need to do something about it.
